Including an Executive Function Model in Everyday School-based Practice

Presented by Steven Guy, Ph.D.

Co-Author of the Behavior Rating Inventory of Executive Function (BRIEF)

This workshop will focus on developing a working understanding of the concepts and assessment methods for the inclusion of an executive function model in everyday school-based practice. Participants will gain a solid foundation in definitions and concepts of executive function and associated subdomains. Application of these concepts to a wide range of clinical disorders and age groups will be presented and illustrated with case material. Clinical groups to be discussed include individuals with Attention Deficit/Hyperactivity Disorder, traumatic brain injury, learning disabilities, anxiety/depression, chronic illness, and High Functioning Autism/Asperger's Syndrome. Methods of identifying and assessing individual's profiles of strengths and weaknesses in the subdomains of executive function, including formal and informal assessment tools, will be reviewed. Participants will learn about the strengths, weaknesses, and applicability of current tests, rating scales, and observational methods. Although basic conceptual material will be presented, the focus of this workshop is a practical, skills-based approach, with a major focus on clinical applications to a variety of developmental, psychiatric, and neurological populations.

Outcomes

Workshop participants will:

- define executive functions and understand underlying concepts
- articulate the range of executive function subdomains
- explain profiles of strengths and weaknesses with various clinical populations
- increase knowledge regarding executive function assessment methods, including the strengths and weaknesses of these methods
- gain exposure and experience in the use (administration, scoring, profile analysis) of selected assessment methods.

Dr. Steven C. Guy is a pediatric neuropsychologist in private practice in Columbus, Ohio, and works with children and adolescents with a wide variety of developmental and acquired conditions. He completed his undergraduate work at Judson College in Elgin, Illinois and his graduate work at DePaul University in Chicago, Illinois. Dr. Guy completed his internship at Children's Hospital in Columbus, Ohio, and a two-year postdoctoral fellowship in neuropsychology at Mt. Washington Pediatric Hospital in Baltimore, Maryland. He is also one of the coauthors of the Behavior Rating Inventory of Executive Function. His research interests include learning disabilities and pervasive developmental disorders. He is continuing his research developing methods designed to assist in the assessment of executive function.
